- In addition to the shares that Mr. Stollenwerk owns directly, he and members of his family are beneficiaries of the Dorothy Stollenwerk Trust, for which he is a Trustee, which holds 5,082 shares of Badger Meter stock. Mr. Stollenwerk also has a deferred stock account for director fees in which he holds 7,504.723 phantom shares of Badger Meter stock. All share amounts have been adjusted to reflect the Company's 2-for-1 stock split as of December 10, 2004.
- Stock Options are granted on a one-for-one basis.

- In addition to the 1,000 stock options remaining in the May 25, 1997 grant, the reporting person has options to acquire 15,200 additional shares of Common Stock at varying grant prices and vesting schedules over a ten-year period. All share amounts have been adjusted to reflect the Company's 2-for-1 stock split as of December 10, 2004.
