- On November 16, 2004, the Reporting Person was issued an option to purchase 166,667 shares of Sunair's common stock as an inducement to entering into an employment agreement with Sunair. The option grant and employment agreement were conditioned upon (1) the closing of a Purchase Agreement, dated as of November 17, 2004, between Sunair and Coconut Palm Capital Investors II, Ltd., which occurred on February 8, 2005. The options will vest over a period of four years from the date of grant. The options were granted outside of the company's stock option plan.
