- Until vested, these shares are subject to (i) certain restrictions on transfer and (ii) forfeiture if the reporting person ceases to be an employee of the Company. These shares are scheduled to vest on January 27, 2009, subject to accelerated vesting upon certain change in control events and subject to accelerated vesting upon certain termination of employment events.
- (1) The increase in shares held directly by the reporting person since such holdings were last reported reflects (i) the acquisition of 4,931 shares acquired in exempt transactions through dividend reinvestment and the Company's employee stock purchase plan and (ii) the acquisition of 10,173 restricted shares through the transaction described in table 1.
