On January 11, 2006, Cleveland-Cliffs Inc ("Company") declared a dividend of \$.20 per share, payable to all holders of record as of February 15, 2006 of common stock payable on March 1, 2006. The amount shown reflects .95 shares acquired pursuant to

(1) Cleveland-Cliffs Inc Dividend Reinvestment and Stock Purchase Plan. The amount also includes 9.987 shares of Restricted Stock acquired March 1, 2006 pursuant to a dividend reinvestment feature of the Company's Nonemployee Directors' Compensation Plan ("Plan").

(2) Convertible into Common Shares on a 1-for-1 basis.

(3) Reflects number of Common Shares credited to the account of the Reporting Person in payment of the Reporting Person's Required Quarterly Retainer for the Second quarter of 2006 under the Plan. Full shares earned in 2006 will be issued effective January 2, 2007.

The total includes a dividend reinvestment feature pursuant to the Plan. The number of deferred dividend reinvestment equivalent shares

(4) earned in the Plan is calculated using the closing market price at the end of each quarter for shares held in the Plan. The reporting person was credited with 3.9625 dividend reinvestment shares on 3/31/2006.
