(1) Reflects stock bonus award of restricted stock units ("RSUs") granted under a Rule 10b-3 plan. Each RSU will automatically be redeemed for one share of Issuer Common Stock (\$.10 par value) upon satisfaction of a service-based vesting condition. RSU's vest to the extent of 50% of the underlying shares on each of the 3rd and 4th anniversaries of the grant date.

Options are exercisable in installments of 25% of the optioned securities on and after the first anniversary of the date of grant and to the extent of an additional 25% of the optioned securities on and after the second, third and fourth anniversary dates.
