  - (2) Autumnwood, Ltd. made a pro rata partner capital distribution to Senior Living Trust on June 15, 2009. James A. Stroud has an indirect interest in the 700,424 shares distributed to Senior Living Trust.
- Because James A. Stroud ("Stroud") is the trustee and sole beneficiary of Senior Living Trust, a trust administered under the laws of the State of Texas (the "Trust") and, thus, controls the Trust, Stroud is deemed to share voting and dispositive power with the Trust. In addition, Stroud holds 10 shares of common stock as custodian for his son.
