- (3) The number of share equivalents reported was determined by dividing the dollar amount credited to the Reporting Person's account by \$32.81 (the closing price for Hanesbrands Inc. common stock on the valuation date of October 15, 2012).
- (4) The balance is determined by dividing the value in the Reporting Person's account following the reported transaction by \$32.81 (the closing price for Hanesbrands common stock on the transaction date of October 15, 2012).
