- (1) received by virtue of (i) pro-rata in-kind distributions of common stock of the Issuer by Ignition Venture Partners without consideration to its partners, including the Reporting Person; and (ii) pro-rata in-kind distributions of common stock of the Issuer by Ignition Managing Directors without consideration to its members, including the Reporting Person. Following these distributions, neither Ignition Venture Partners nor Ignition Managing Directors holds any shares of common stock of the Issuer.
- (2) The reported shares are represented by restricted stock units which vest in full on the earlier of the day prior to the Issuer's next annual meeting or June 13, 2014.
