The reporting person was granted multiple restricted stock units that vest upon the achievement of certain defined performance milestones. On August 11, 2014, one of the defined performance milestones was met, resulting in the partial vesting of the restricted stock units.

(1) Shares withheld to satisfy the tax liability incident to the vesting of previously reported restricted stock units.

(2) Acquired pursuant to a Restricted Stock Unit Award: 25% vest on each year anniversary of the vesting determination date and 25% each anniversary thereafter; shares fully vest on the fourth year anniversary of the vesting determination date.

(3) Shares sold to fund the establishment of a charitable fund.

The price reported in Column 4 is the weighted average price. These shares were sold in multiple transactions at prices ranging from \$7.00 to \$7.07, inclusive.
