- (1) Each performance share was granted in 2012 and represented a contingent right to receive between 0 and 2 shares of Chemtura Corporation common stock based on Chemtura Corporation's total shareholder return against the companies comprising the Russell 3000 Index (the "TSR Metric"). 10,322 shares of common stock represented the target amount of the award granted in 2012. The performance shares vested at 191.16% of the target amount based on the TSR Metric, for a total payout of 19,731 shares of common stock.
