- (1) The restricted stock units granted on May 5, 2016 will vest 100% at the anniversary of the grant date. This is an annual non-employee director grant as outlined in the 2016 proxy.
- Mr. Beard has been granted a total of 26,000 shares in three grants; (A) 10,000 RSUs granted May 8, 2014 which vest annually in in 4 equal installments on each anniversary of the grant date until fully vested; (B) 8,000 RSUs granted 5/7/2015 and (C) 8,000 RSUs granted 5/5/2016. A & B vest 100% at the anniversary of the grant date. December 8, 2014 he purchased 10,000 shares and March 30, 2016, he purchased an additional 10,000 shares as part of two 10b5-1 plans. As of the reporting date, 2,500 shares have vested and he holds 22,500 shares in street name.
