- (1) Acquisition of IGT common stock on vesting and disposition of IGT restricted stock unit award.
- (2) The restricted stock units vest in three equal annual installments commencing on the earlier of the first anniversary of the award date or the date of the Issuer's annual meeting of stockholders.
- (3) Each restricted stock unit represents a contingent right to receive one share of IGT common stock.

The restricted stock units will vest upon the first to occur of (a) the first anniversary of the date of grant of the award or (b) the day before (4) the Issuer's annual meeting of stockholders that occurs in the first fiscal year after the fiscal year in which the date of grant occurs. Vested units will be paid in connection with the reporting person's separation from service or a change in control of IGT, whichever occurs first.
