(a) Amount Beneficially Owned:

Tang Capital Partners. Tang Capital Partners is the beneficial owner of 459,442 shares of the Issuer's Common Stock, which is comprised of: 181,236 shares of the Issuer's Common Stock, 4,615.81 shares of the Company's Series C-12 Convertible Preferred Stock, par value \$0.0001 per share (the "Series C-12 Preferred") and 175.78 shares of the Company's Series F Convertible Preferred Stock, par value \$0.0001 per share (the "Series F Preferred").

The Series C-12 Preferred and the Series F Preferred can only be converted into Common Stock to the extent that, after such conversion, the holder would beneficially own no more than 9.999% of the Issuer's Common Stock.

Tang Capital Partners shares voting and dispositive power over such shares and preferred stock with Tang Capital Management and Kevin C. Tang.



Tang Capital Management. Tang Capital Management, as the general partner of Tang Capital Partners, may be deemed to beneficially own the shares of the Issuer's Common Stock and preferred stock beneficially owned by Tang Capital Partners.

Kevin C. Tang. Kevin C. Tang, as manager of Tang Capital Management, may be deemed to beneficially own 468,214 shares of the Issuer's Common Stock, comprising:

The shares of the Issuer's Common Stock and preferred stock beneficially owned by Tang Capital Partners; and

8,772 shares of the Issuer's Common Stock, 211.52 shares of the Company's Series C-12 Preferred and 8.05 shares of the Company's Series F Preferred; all over which Mr. Tang has shared voting and/or dispositive power.

Mr. Tang disclaims beneficial ownership of all shares reported herein except to the extent of his pecuniary interest therein.

The shares of the Issuer's Common Stock reported herein are adjusted to reflect the Issuer's one-for-fifty reverse stock split.

The percentages used herein are based upon 4,682,613 shares of Common Stock outstanding (4,404,407 shares outstanding (220,220,368 reported pre-reverse split) as of December 19, 2013 per the Registration Statement on Form S-8 as filed with the Securities and Exchange Commission on December 20, 2013, plus 278,206 shares of Common Stock issuable upon conversion of preferred stock).
