The effective date of the Merger is January 18, 2012. - (3) This option has a vesting schedule of one fourth vesting on February 7, 2012 and the remainder vesting in 36 equal monthly installments thereafter.
- (4) Options assumed/converted in connection with the Merger into options to acquire the same number of ordinary shares of Jazz Pharmaceuticals plc at the same exercise price and on substantially the same terms.
