- (2) Restricted Stock Units upon satisfaction of both the performance and service vesting requirements but has accelerated its reporting of these Restricted Stock Units to correspond with Compensation Committee certification of satisfaction of the performance vesting requirements.  
These Restricted Stock Units include an initial grant of 6,365 Restricted Stock Units, plus dividend equivalents accrued through the
- (3) transaction date in the form of additional Restricted Stock Units that vest and are paid at the same time and in the same manner as the underlying Restricted Stock Units.
