GOL Announces Traffic Statistics for September 2005

São Paulo, October 4, 2005 GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low fare, low cost airline, today released preliminary passenger statistics for the month of September 2005. System-wide passenger traffic (RPK) increased 78%, while capacity (ASK) increased 59%. GOL's system load factor for the month of September 2005 was 76%.

Domestic passenger traffic (RPK) for September increased 68%, while capacity (ASK) increased 50%. GOL's domestic load factor for the month was 76%.

Compared with the previous month, international passenger traffic (RPK) for September increased 56%, while capacity (ASK) increased 44%. International load factor for the month of September 2005 was 72%.
