NOTICE TO THE MARKET

São Paulo, July 1, 2015 - Braskem (BM&FBovespa: BRKM5, BRKM3, BRKM6; NYSE: BAK; LATIBEX: XBRK), announces that, jointly with other electro-intensive industries in Brazil's Northeast region, filed a lawsuit, and had an injunction granted to ensure that Companhia Hidro Elétrica do São Francisco – Chesf will not interrupt the power supply to its industrial units and will continue to supply it under the conditions set by Provisional Measure 677/15, published on June 23, 2015 (“MP”).

Although the negotiation between Chesf and the companies has advanced, the short time between the publication of the MP and the end of the current contracts, yesterday, proved insufficient to enable the parties to reach an understanding on certain clauses of the new contractual amendments. As a result, the companies resorted to the Judiciary to ensure their right to power supply entitled thereto under the MP, without prejudice to the ongoing negotiations with Chesf.
