As a result of above mentioned sale, the equity interest held by BNDES Participações S.A. – BNDESPAR, equivalent to 10.00% of Braskem’s class “A” preferred capital and 4.33% of Braskem’s total capital as of February 17, 2016, has been reduced to 5.00% and 2.16%, respectively.
