**Item 3.02 Unregistered Sales of Equity Securities.**

1) New Issuances

On April 17, 2006, Wave Wireless Corporation (the "Registrant") closed the sale of 108 shares of its Series J Convertible Preferred Stock (the "Series J Preferred Stock"). On that date, the Registrant received gross proceeds of Eight Hundred Ten Thousand Dollars (\$810,000) from accredited investors. The net proceeds to the Registrant were Seven Hundred and Four Thousand Dollars (\$704,000) after the payment of a 10% placement fee to the placement agent and legal fees in the amount of \$25,000. Pursuant to the terms of the transaction, the investors also received 3,240,000 Series J Warrants to purchase the Company's common stock. The Series J Warrants have an exercise price of \$0.12 per share of common stock and expire five years from the date of issuance.

The sales of securities described above have not been registered under the Securities Act of 1933, as amended (the "Securities Act") and were made in reliance upon the exemption from registration available under Regulation D promulgated under the Securities Act. This exemption was claimed on the basis that the transactions did not involve any public offering and the purchasers provided written assurances that they were accredited investors (as defined in Rule 501(a) of the Securities Act). The securities were, or shall be, issued with the appropriate restrictive legend indicating that they may not be offered or sold absent registration or an applicable exemption from registration requirements.

2) Exchange of Securities

In connection with the merger of the Registrant with WaveRider Communications Inc., an investor exchanged its holdings of: (i) 1,326,446 shares of Series H convertible preferred stock; (ii) 132,6446 shares of Series I convertible preferred stock; and (iii) Warrnats to purchase 8,842,089 shares of common stock of the Registrant, at an exercise price of \$0.20 per share, for 353,7333 shares of Series J Convertible Preferred Stock and Series J Warrants to purchase 10,612,000 shares of common stock of the Registrant. Each Series J Warrant is exercisable at an initial exercise price of \$0.12 per share and has a term of five years.
