(1) Shares acquired upon vesting of restricted units awarded under the Issuer's Long-Term Incentive Plan on January 20, 2005. The units vested in full on January 20, 2008. Restricted units were payable one third in cash and two thirds in shares of the Issuer's common stock.

(2) FMV of a share of issuer's common stock on date of vesting.

(3) The amount of securities beneficially owned following the reported transactions includes shares of common stock acquired under the ONEOK, Inc. Direct Stock Purchase and Dividend Reinvestment Plan as well as shares of common stock acquired pursuant to dividend reinvestment features of the ONEOK, Inc. Employee Stock Purchase Plan and the ONEOK, Inc. Thrift Plan which acquisitions are exempt under Rule 16a-11.

(4) Shares surrendered to pay tax liability due at vesting of Restricted Units.

(5) Restricted stock incentive units awarded under the Issuer's Long-Term Incentive Plan. The award vests on January 20, 2008, and is payable one-third in cash and two-thirds in shares of the Issuer's common stock based on FMV of one share of Issuer's common stock on date of vesting. The amount set forth in Column 5 represents the two-thirds portion of the grant payable in shares of the Issuer's common stock.
