- (1) On June 29, 2018, 11,771 performance-vesting restricted stock units held by Mr. Wereb vested. Pursuant to the terms of his restricted stock unit award agreement, the Company withheld 5,837 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation. As the performance conditions underlying this restricted stock unit award were not achieved at the maximum level, 778 previously reported restricted stock units did not vest.
- (2) Following the transactions reported on this Form 4, Mr. Wereb held (a) 10,393 shares of the Company's common stock and (b) 26,261 performance-vesting restricted stock units, each representing the right to receive one share of the Company's common stock.
