Pursuant to a restricted stock unit award agreement dated 05/22/2012, the reporting person was granted 5,000 restricted stock units - data received from plan administrator on 05/24/2012. The restricted stock units will vest 1,000 on each of 07/01/2013, 05/22/2014, (3) 05/22/2015, 5/22/2016, and 05/22/2017. Upon vesting, Apache will issue one share of common stock for each restricted stock unit, and 600 shares out of each 1,000 shares will not be eligible for sale by the reporting person until such time as he retires or otherwise terminates employment with the company.

The shares of common stock of Apache are deemed to also represent certain preferred stock purchase rights ('Rights'). The Rights are not (4) currently exercisable or separately tradable and presently are evidenced by certificates for shares of the common stock. Value attributable to such Rights, if any, is reflected in the market price of the common stock.
