On January 2, 2019, the reporting person received 804 shares of ARMOUR common stock pursuant to quarterly compensation paid for the reporting person's service on ARMOUR's Board of Directors. The 804 shares of stock represent the reporting person's election of stock compensation for the past quarter.
