ITEM 5.07 SUBMISSION OF MATTERS TO A VOTE OF SECURITY HOLDERS

On May 10, 2016, National Bankshares, Inc. held its 2016 Annual Meeting of Stockholders (the “Annual Meeting”). A total of 6,957,974 shares of the Company’s common stock were entitled to vote as of March 16, 2016, the record date for the Annual Meeting. There were 6,030,946 shares, or 86.68%, present at the Annual Meeting in person or by proxy which constituted a quorum, and the stockholders voted on three proposals.

Proposal No. 1 – Vote on Directors

The stockholders elected three Class 2 directors to serve a three-year term expiring at the Company’s 2019 Annual Meeting of Stockholders. The results of the vote were as follows:

The terms of office of the following directors who did not stand for re-election continued after the Annual Meeting: Lawrence J. Ball, Charles E. Green, III, Mary M. Miller, William A. Peery, Glenn P. Reynolds, and James M. Shuler.

Proposal No. 2 – Advisory Vote to Approve Named Executive Officer Compensation

The stockholders approved a non-binding advisory vote to approve the compensation of the Company’s named executive officers. The results of the vote were as follows:

Proposal No. 3 –Ratification of Appointment of Independent Public Accounting Firm

The stockholders voted to ratify the Company's Board of Directors' appointment of Yount, Hyde & Barbour, P.C. to serve as its independent registered public accounting firm for the fiscal year ending December 31, 2016. The results of the vote were as follows:
