- (1) Applied Minerals, Inc. (the "Company") sold to Overlook Investment LLC ("Overlook"), of which Mr. Zamani is majority owner, 312,500 shares of common stock at \$0.08 per share. The purchase also included an issuance to Overlook of 312,500 warrants to purchase shares of common stock. Each warrant allows Overlook to purchase one share of common stock for \$0.15. The term of each warrant is three years.
