- (1) Each phantom unit is the economic equivalent of one common unit.  
One-third of the phantom units (rounded down to the nearest whole number of units, except in the case of the final vesting date) vested on March 15, 2014, with the remaining phantom units subject to the original award vesting in equal installments on each of the second and third anniversaries of the March 15, 2013 grant date, subject to continued employment. The Reporting Person received distribution equivalent rights (DERs) for each phantom unit, providing for payment on the vesting date of a lump sum of cash equal to the accrued distributions from and after the grant date of the phantom units.
  - (3) The phantom units and associated DERs do not expire. The phantom units are settled upon vesting in common units (on a one-for-one basis) or in cash, at the discretion of the Issuer.
  - (4) One-third of the phantom units (rounded down to the nearest whole number of units, except in the case of the final vesting date) shall vest on each of the first, second and third anniversaries of the March 15, 2014 grant date, subject to continued employment.
