On the day prior to the effective date of the Merger, the closing price per share of NCLH common stock was \$41.77 and the value per share of PCI common stock as of the closing of the Merger was \$30.92. The amount of NCLH common stock reported as beneficially owned by the reporting person following the Merger does not include 286 shares that are currently being held in escrow in the name of the escrow agent and are subject to forfeiture during the nine (9) months following the closing date of the Merger to satisfy indemnification obligations arising under the merger agreement.
