- (1) On September 9, 2011, the Reporting Person received a grant of restricted stock units ("RSUs") covering 4,800 shares of KLA-Tencor common stock. On September 9, 2015, the Reporting Person vested in fifty percent (50%) of such RSUs.

- (2) Pursuant to the terms of the September 9, 2011 RSU grant, 1,253 shares of KLA-Tencor common stock were automatically withheld on the vesting date to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
