Pursuant to the Agreement and Plan of Merger, dated as of June 18, 2018, entered into by and among Cheniere Energy Partners LP Holdings, LLC (the "Company"), Cheniere Energy, Inc. (the "Reporting Person") and Columbia Acquisition Sub LLC ("Merger Sub"), the Company merged with and into Merger Sub, with Merger Sub continuing as the surviving entity and a wholly-owned subsidiary of the Reporting Person.
- (3) As a result of the merger, each common share representing limited liability company interests in the Company ("Company Common Shares") held directly or indirectly by the Reporting Person immediately prior to the effective time of the merger was cancelled without payment of consideration therefor and the remaining Company Common Shares were converted into the right to receive 0.4750 shares of common stock, par value \$0.003 per share, of the Reporting Person and cash in lieu of any fractional Company Common Shares.
