- (1) On May 17, 2013, the reporting person exercised 12,500 stock options, delivered 5,548 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 2,569 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding. These shares cancellations are shown on Table I as dispositions (Transaction Code "D" in column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in column 3.
