- (1) Settlement of Performance Rights which were awarded by the Board's Compensation Committee on 2/17/2012 pursuant to the Nordstrom, Inc. 2010 Equity Incentive Plan. The Performance Rights vested on 2/13/2015, based upon the Compensation Committee's determination that the applicable performance criteria had been met as of 1/31/2015. 2,217 shares vested of which 84 shares were withheld for taxes. The reporting party elected to defer the balance of 2,133 shares to the Executive Deferred Compensation Plan.
- (2) Exercise of tax withholding right upon settlement of Performance Shares. The tax withholding right was previously approved by the Board's Compensation Committee at the time of the Performance Share grant.
