Explanation of Responses:

- (1) Shares held by Mr. Bourne, custodian for minor children (Robert Kyle Bourne and Conner R. Bourne) UGMA.
- (2) Shares held by four limited partnerships of which Mr. Bourne is a general partner. Mr. Bourne disclaims beneficial ownership of these except to the extent of his respective shares percentage interest in each of these securities.
- (3) Shares held by The Robert A. Bourne Irrevocable Trust #1 in which Mr. James M. Seneff, Jr. is a Trustee and Mr. Bourne's minor children are the beneficiaries.
- (4) Shares acquired by Robert Kyle Bourne and are held in an account named Robert Arthur Bourne Custodian for Robert Kyle Bourne UFLUTMA Until Age 21.
- (5) Shares acquired in Mr. Bourne's 401-K account.
- (6) Stock options were granted under the Commercial Net Lease Realty, Inc. 2000 Performance Incentive Plan in a transaction exempt under Rule 16b-3. The options are exercisable in cumulative one-third installments commencing one year from the date of the grant, with full vesting occurring on the third anniversary date.
