- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 3,293 units were acquired at prices ranging from \$63.40 to \$71.30. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 297 units were acquired at prices ranging from \$64.99 to \$70.30. These transactions are exempt under rule 16a-11.
- (3) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 94 units were acquired at prices ranging from \$64.99 to \$70.30. These transactions are exempt under rule 16a-11.
