**General Rate Case Decision**

On July 8, 2004, the California Public Utilities Commission issued a final decision in Southern California Edison Company's 2003 general rate case. Southern California Edison is the largest supplier of electricity in California. The general rate case decision authorized an annual increase of approximately 2.5% in base rates. Southern California Edison had requested an increase of about \$250 million.

The decision is retroactive to May 22, 2003, when the decision initially was forecasted. The balance in the account established to record the recovery of the authorized rate increase since May 22, 2003, will be recovered in rates over the next 12 months. To stabilize customer rates, Southern California Edison proposed that the general rate case decision be combined with several other rate-related proceedings. Southern California Edison estimates that the outcome of this consolidated rate decision will decrease average rates for bundled service customers by 0.34%.

The general rate case decision approves nearly all of Southern California Edison's request for its multi-billion infrastructure investment program through 2005. This program is essential to provide the levels of electric grid reliability. The decision also establishes revenue adjustments for 2004 to cover cost escalation and planned capital investments.

The decision rejects Southern California Edison's requested increase in depreciation to cover the disposal costs of retired equipment, instead choosing to shift recovery of about \$114 million annually. The balance of the reduction in Southern California Edison's request is primarily in the capital-related ratemaking adjustments of about \$42 million, and operations and maintenance expenses of about \$10 million.

While Southern California Edison's case was pending before the California Public Utilities Commission, the company identified \$28 million of supplemental costs being incurred above the general rate case. The commission's final decision did not recognize these cost increases, which are primarily in the transmission and distribution operations. Southern California Edison intends to review its operations to align its costs with the authorized revenues.

Southern California Edison is planning to submit a notice of intent for its 2006 general rate case in the summer and then file a formal application in the fall once it has met the California Public Utilities Commission's standard for completeness. In this upcoming application, Southern California Edison requests to establish appropriate levels of operating and depreciation expenses.
