#### Item 8.01 Other Events

On January 10, 2005, Edison Mission Energy ("EME"), a subsidiary of Edison International, acquired an equity interest in the Caliraya-Botocan-Kalayaan hydroelectric power project located in Laguna Province, Philippines (the "CBK Project") to CBK Projects B.V., the purchasing entity designated by its parent company, Project, Corporacion IMPSA S.A. ("IMPSA"), for a purchase price of approximately \$104 million. As previously reported in Edison International's Current Report on Form 8-K filed December 21, 2004, under Commission file number 04-100000, EME had previously entered into a Purchase Agreement with IMPSA, dated as of November 5, 2004, to acquire an equity interest in the CBK Project.
