(d) Appointment of Katrina Helmkamp as Director

On November 5, 2015 the Board of Directors of IDEX Corporation (the "Company") appointed a new director, Katrina Helmkamp. Ms. Helmkamp will receive a compensation package commensurate with other non-employee directors. She will receive an initial equity grant of \$32,100 effective with her appointment, an annual equity grant of \$110,000 and an annual retainer of \$75,000.
