- (1) These shares of common stock are issuable pursuant to awards of restricted stock units that vest in three annual installments, with 33.4% vesting on the first anniversary of the grant date and 33.3% vesting on each of the second and third anniversaries of the grant date. Of these shares, 2,000 shares were granted on March 30, 2012, 4,753 shares were granted on March 29, 2013, 4,741 shares were granted on March 28, 2014, 1,000 shares were granted on May 1, 2014 and 3,000 shares were granted on December 1, 2014.
- (2) These stock options vest at a rate of 1/3 of the shares underlying the stock option one year from the date of grant and at a rate of 1/36 monthly thereafter.
