(1) Point Pleasant Ventures Ltd. is a British Virgin Islands company that is wholly owned by G&S Trustees Limited, in its capacity as trustee of the Lagrange GLG Trust (the "Trustee"), to which the Trustee transferred 58,900,370 shares of common stock held by the Trustee directly on March 19, 2008, resulting in a change in the form of ownership by the Trustee from direct to indirect. The Lagrange GLG Trust is a trust established for the benefit of Pierre Lagrange and his family. Neither the Trustee nor Point Pleasant Ventures Ltd. has any pecuniary interest in the shares. This amendment restates the reporting on Table I of the original Form 3 to show the shares of common stock as beneficially owned by Point Pleasant Ventures Ltd.
