This amendment is being filed to report an increase of shares of Common Stock held by the Reporting Person due to the Reporting Person s right to acquire an additional 125,000 shares upon the exercise of options which are currently exercisable. On January 24, 2007, a five-year stock option to purchase 125,000 shares of the Issuer s Common Stock at \$0.77 per share was granted by the Issuer to the Reporting Person, which option is immediately exercisable.

#### Item 5. <u>Interest in Securities of the Issuer</u>.

The Reporting Person beneficially owns an aggregate of 3,677,125 shares of Common Stock of the Issuer, representing 27.5% of the shares of Common Stock of the Issuer. Such amount does not include 2,531,343 shares, a warrant to purchase 670,782 shares and options to purchase 475,000 shares held by the Reporting Person s spouse, as to all of which the Reporting Person disclaims beneficial ownership. Of the shares beneficially owned by the Reporting Person, 2,531,343 shares are held directly by the Reporting Person, 670,782 shares are obtainable upon exercise of a currently exercisable warrant and 475,000 shares are obtainable upon exercise of options which are currently exercisable. The options were granted pursuant to the Issuer s 2004 Equity Incentive Plan. The Reporting Person has sole voting and dispositive power over all of the Common Stock and rights to acquire Common Stock currently owned by him. Except as described in Item 4 above, the Reporting Person has not engaged in any transaction during the past 60 days in any securities of the Issuer.
