Mr. Cohen controls each of SAC Capital Advisors Inc., CR Intrinsic Investors and Sigma Management. CR Intrinsic Investments and SAC Select Fund are wholly owned subsidiaries of SAC Capital Associates. As of December 31, 2013, by reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) SAC Capital Advisors LP, SAC Capital Advisors Inc. and Mr. Cohen may be deemed to beneficially own 626,642 Shares (constituting approximately 1.3% of the Shares outstanding); (ii) CR Intrinsic Investors and Mr. Cohen may be deemed to beneficially own 264,300 (a) Shares (constituting approximately 0.5% (a) of the Shares outstanding); and (iii) Sigma Management and Mr. Cohen may be deemed to beneficially own 1,178,841 (b) Shares (constituting approximately 2.4% (b) of the Shares outstanding).
