- (1) Restricted Stock granted on August 24, 2015 will vest in 33 1/3% installments over five years beginning on the third anniversary of the award date.
- (2) Restricted Stock granted on August 2, 2012 "cliff" vested 100% three years from award date.
- (3) The reporting person had 4,000 shares vest since the last filing.
- (4) The Performance Stock awarded on August 24, 2015 will vest in 33 1/3% installments over five years beginning on the third annual anniversary of the date that the performance goal is met.
