- The governance, investment strategy and decision-making process with respect to the investments held by the Bain Entities is directed by BCI's Global Private Equity Board ("GPEB"). Joshua Bekenstein is a member of GPEB and a Managing Director of BCI. By virtue of the relationships described in these footnotes, Mr. Bekenstein may be deemed to share voting and dispositive power with respect to the shares of Common Stock held by Bain Entities. Mr. Bekenstein disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
- (7) On November 18, 2015 the Bain Entities distributed 265,917 shares of Common Stock to one or more members or partners of the Bain Entities, including 81,651 shares to Mr. Bekenstein, in connection with certain charitable gifts made by such members or partners on November 18, 2015.
- (8) Mr. Bekenstein made a charitable gift of all 81,651 shares of Common Stock that he received in connection with the distribution.
- (9) Each Restricted Stock Unit vests upon grant and represents the right to receive one share of Common Stock upon the earlier of May 11, 2020 or Mr. Bekenstein's termination of service.
