In a letter to Trump Entertainment Resorts, Inc. (the "Company" or the "Registrant") dated September 7, 2010, John P. Burke resigned from his positions with the Company and its affiliates, including the position of Chief Financial Officer of the Company, effective September 17, 2010. Upon Mr. Burke's resignation, his employment agreement will terminate in accordance with, and to the extent provided by, its terms. Following the effective date of his resignation, provided that he enters into a customary mutual release in the form required by the Company, Mr. Burke will be entitled to severance pursuant to the terms of his employment agreement in accordance with provisions thereof that apply following a "change-of-control" of the Company.
