The Registrant's net loss for the year ended December 31, 2003 was NIS 12,987,000 (NIS 2.17 per share), compared with net loss of NIS 15,714,000 for the year ended December 31, 2002 (NIS 3.22 per share). These losses are attributable to the weak global electronic market, especially the weakness in the Israeli market.
