 - (1) Includes 110,766 shares owned by the Estate of William Shaw (the "Estate"). As co-executrix of the Estate, the reporting person may be deemed to directly beneficially own those shares of which she is the beneficiary. The reporting person's sister, Deborah Shaw, also has a beneficial interest in shares held by the Estate. Also includes 1,492,997 shares held in three trusts for the reporting person's benefit of which the reporting person is the sole trustee.
 - (2) Represents 2,600 shares distributed by the Estate to a child of Deborah Shaw, the reporting person's sister, and 10,400 shares distributed by the Estate to Deborah Shaw's spouse as custodian under the California Uniform Transfers to Minors Act.
 - (3) Represents shares owned by the Estate which shares will ultimately be distributed to or for the benefit of Deborah Shaw, the reporting person's sister.
 - (4) The filing of this statement shall not be construed as an admission that the reporting person is, for purposes of Section 16 of the Securities Exchange Act of 1934 or otherwise, the beneficial owner of these securities.
 - (5) Held by the reporting person as co-trustee of trusts for the benefit of her children. Bruce Goodman, the reporting person's spouse, and Deborah Shaw, the reporting person's sister, are also co-trustees of these trusts.
 - (6) Includes 500 restricted shares as to which the restrictions generally lapse one-third each year.
