- (1) Vesting of restricted stock based on the achievement of certain company initiatives over the 2006-2008 period; 100% of the stock vested.
 - (2) This information is based on a plan statement dated 12/31/2008.
 - (3) One third of the option vested on 2/15/2008, and one third vests on each of 2/15/2009 and 2/15/2010.
 - (4) One third of the option vests on each of 2/13/2009, 2/13/2010, and 2/13/2011.
 - (5) One third of the option vests on each of 2/11/2010, 2/11/2011, and 2/11/2012.
 - (6) The transaction was an option grant. Accordingly, the reporting person did not pay a price to obtain the option.

 - (8) The stock vests on the achievement of certain company initiatives over the 2007-2009 period.
 - (9) The stock vests on the achievement of certain company initiatives over the 2008-2010 period.
The restricted stock units may be earned based on the achievement of certain company goals during 2009. Assuming continued employment on the payment date, which will occur within 30 days after the end of fiscal 2011, the units will then vest in one installment and shares will be issued.
 - (10) If the company achieves certain goals over the 2009-2011 period, the performance units will vest and stock will be awarded.
 - (11) Payment will begin within 30 days first beginning after the earliest of the date specified in advance of the deferral by the reporting person, death, disability, retirement or termination of employment.
 - (12) Includes 6.555 deferred stock units acquired through exempt dividend reinvestments.
