Dr. Frost, the Chairman of the Board and a principal shareholder of the Company, is also the Chairman of the Board, Chief Executive Officer and a principal shareholder of IVAX Corporation and Neil Flanzraich, a director of the Company, is Vice Chairman and President of IVAX Corporation. Mr. Pfenniger, the Company's Chief Executive Officer and a director, is also a director of IVAX Corporation.
