Pursuant to the instructions of Item 7 of Schedule 13G, Vanguard Fiduciary Trust Company ("VFTC"), a wholly-owned subsidiary of The Vanguard Group, Inc., is the beneficial owner of 393,527 shares or .13% of the Common Stock outstanding of the Company as a result of its serving as investment manager of collective trust accounts.
