TERMINATION OF REGISTRATION

On October 24, 2007, pursuant to the Agreement and Plan of Merger, dated as of July 3, 2007, among Hilton Hotels Corporation (the <u>Company</u>), BH Hotels LLC, a Delaware limited liability company (<u>Parent</u>), and BH Hotels Acquisition Inc., a Delaware corporation (<u>Merger</u> Sub), Merger Sub merged with and into the Company (the <u>Merger</u>), with the Company being the surviving entity and becoming a wholly-owned subsidiary of Parent. As a result, the Company has terminated all offerings of its securities pursuant to the Company s Registration Statement on Form S-3 (File No. 333-107159) (as amended, the <u>Registration Statement</u>). In accordance with an undertaking made by the Company in its Registration Statement to remove from registration, by means of a post-effective amendment, any securities which remain unsold at the termination of the offering, the Company hereby removes from registration all securities under the Registration Statement which remained unsold as of the effective time of the Merger.
