Capital Group International, Inc. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 52,282,380 shares or 7.3% of the 720,880,604 shares of Ordinary Shares, including American Depositary Shares, believed to be outstanding.
